- 3. Committee Reports
 - a. Communications from the past month
 - i. Facebook page postings:
 - Recycling pickups
 - Hit and run on a parked car located on Azalea Drive
 - Old Arby's now an African restaurant
 - ii. Website: minutes from April 2024 posted
 - b. Social: No activity
 - c. Maintenance:
 - i. Two quotes expected for grading and seeding of old pool site

- 4. Unfinished Business
 - a. Lightting of entrance signs: need bracket for new solar light: Dennis to contact David Monnier who offered his friend's assistance to weld a bracket for a light.
 - b. Baby pool and shed pit now filled with concrete: can repurpose spaces
 - i. Patio area can be now opened up for renters of the clubhouse may need more seating
 - ii. Shed can now be reorganized
- 5. New Business
 - a. Board of Directors:
 - i. Reporting requirements under the CTA no longer apply to U.S. entities meaning that we no longer are required to file the "Beneficial Owner Interest" report with Treasury
 - ii. Eads & Murray Spring Dinner
 - Fishers Rental Ordinance explained
 - Neighbor to Neighbor disputes and the FHA HUD guidelines of 2016 checking with Indiana Farm Bureau Insurance on protection from claims
 - b. Capital Projects to pursue:
 - i. Pickleball court(s): ~\$35k per court
 - ii. Swing set will need to replace collecting ideas (e.g. climbing sets)
 - iii. Water faucet to outside of clubhouse and/or shed
 - c. Spring Neighborhood Cleanup Day
 - i. KIB dumpsters are not available until July
 - ii. Neighbor inquired about a dumpster: if enough interest by neighbors before July, can rent one from Republic or Waste Management (need to be careful of additional "overweight" charges)

- iii. Brainstormed a preliminary work list:
 - Shed reorganization and cleanup
 - Dead limb removal on common areas
 - Pull weeds on mounds and along Dellwood Creek
 - Mulch around bushes at clubhouse, playground, and entrances
- iv. Potential weekends: July 12, 19, or 26

- a. Bank Balance: \$28,231.69; Money Market: \$100,222.07; Total: \$128,453.76
- b. Due collected so far in 2025: \$60,707
- c. 57 residents have not paid 2025 dues as of yet
- d. Tula Concrete and NVB Playgrounds are fully paid
- e. Collections update:
 - i. Moving forward with two additional lien foreclosure suits (this will total three open suits)
 - ii. Moving forward with an additional lien
 - iii. Pursuing wage garnishment with four members
 - iv. One member making payments through collections (Eads & Murray)
 - v. Total owed to Twin Oaks Club by ten owners in collections: \$14,167.56 (these members owe an additional \$8,292.02 in attorney and court costs).
